Careers Programme & Provider Access Policy

Kettlebrook

Introduction

This policy statement sets out the school's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997. As well as the careers overview programme that is accessible for all students at Kettlebrook Short Stay School (KSSS).

Careers Leaders

At KSSS we have a team of Careers staff: Kelly Wright the Level 6 Careers Advisor. Kirsty Sultan is the link between staff and students, inviting guests in etc. Faye Perry is the PSHE Coordinator (Careers taught through PSHE), Kirsty Rogers is the Headteacher with strategic responsibility. Ashley Stops is our WEX Coordinator. John Brodie is Management Committee Governor.

- * Kelly Wright is the independent careers advisor:
- is presented in an impartial manner, showing no bias or favouritism towards a particular institution, education or work option;
- includes information on the range of education or training options, including apprenticeships and technical education routes;
- is guidance that the person giving it considers will promote the best interests of the pupils to whom it is given.

Student entitlement

All students in years 7-11 are entitled: KSSS mainly has 70% KS 4 students.

- to find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- to hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events;
- to understand how to make applications for the full range of academic and technical courses.

 In Yr 11 – all students have 1:1 IAG from Entrust Careers Service from January to May and from August to September if required.

Opportunities for access

A number of events are integrated into the school careers & PSHE programme, as well as specific events that are organised (as and when opportunities arise) to enable all students to have access to careers information. KSSS also offers providers an opportunity to come into school to speak to student and/or their parents/carers during the academic year.

KS 4 students also can have the opportunity to undertake a weekly Work Experience (WEX)Placement which sill compliment their Individual Learning Plan and their POST 16 aspirations. All H&S checks are undertaken before the placement commences, this includes the student having interviews to achieve the WEX placement.
